## BYLAWS

### ELIGIBILITY FOR MEMBERSHIP

1. Any individual who is capable and who has attained the age of 16 and who is ordinarily a resident of Moose Jaw & District, may apply for regular membership.

### MEMBERSHIP FEES

2. The membership fees and the term of membership for each class of membership shall be prescribed by vote of the members.

### DIRECTORS

3. A director is required to be a member of the corporation.
4. See Schedule 2

### OFFICERS

5. The President shall preside at all general meetings of the corporation and at all director's meetings and he/she shall be ex officio a member of all Committees.
6. The Vice-President shall perform the duties of the President in his/her absence or inability to act.
7. The directors may appoint such other officers as may be required and shall assign duties to them.

### MEETINGS OF MEMBERS

8. Meetings of members of the corporation shall be held at Moose Jaw within 90 days of the fiscal year end of the corporation.
9. The fiscal year end shall be March 31 of each year.
10. Six members shall constitute a quorum for a meeting of members.
11. Directors or members may be dismissed at a regular meeting by the membership for committing nefarious acts.
12. "ROBERTS RULES OF ORDER" is the format in which all meetings will be conducted.
13. All executive positions will be two (2) years long with a one (1) year overlap effective April 2011.

### **CLASSES OF MEMBERSHIPS**

## **SCHEDULE 2**

### **OTHER PROVISIONS**

#### **DIRECTORS**

1. Any resolution admitting a person as a member is effective immediately after the payment of their annual dues.
2. A vacancy among the directors shall only be filled by a vote of the members.
3. A quorum at a meeting of directors shall consist of 4 directors.
4. An officer of the corporation is, by virtue of his office, a director of the corporation.
5. Directors may not undertake any major financial commitment without a supporting vote at a general meeting.
6. Directors may not delegate their authority.
